NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Installation of a Datavideo PTC-140 camera above the screen door at the west end

Introduction of two 75 inch TVs on free standing stands, with one on the north side either in or in front of the pulpit and one on the south side behind the worship band area

Installation of two 24 inch monitors in the chancel, on wall mounted brackets behind the north and south chancel arch pillars

Replacement of existing sound desk with a digital Allen and Heath QU16 sound desk to be located at the west end of the north aisle

Associated equipment including vision mixer, two 21.5 inch preview monitors, additional power sockets, wiring and cabling discretely located where required

A letter of objection must include your name and address and state whether you live in the parish and/or your name is entered on the church electoral roll of the parish or any other basis on which you have an interest in the matter.

Directions to petitioner

You must display this public notice (or a copy of it) for a continuous period of not less than 28 days, not counting the day on which it was put up or the day on which it is taken down, (or for such other period as the Court may direct and subject to any special directions of the registrar) in each of the following places:

1. on a notice board or in some other prominent position inside the church; and
2. on a notice board outside the church or in some other prominent position (whether on the outside of the church door or elsewhere) so that it can be read by the public.
